Membership has its Privileges

PAC Annual Membership:

This membership entitles you to all the privileges of an annual member except for unlimited riding.

This is a "Pay as you go" membership where you pay a reduced daily pass of \$20 (Weekday or Weekend) instead of the Normal Daily Pass rates.

Who should become a "PAC Member".

Steady and frequent Riders who ride weekends or once or twice a month.

The savings on the Daily Pass Fee after just a few visits will pay you back for the initial Membership Fee.

Single Annual Membership:

This is for Single Adults (18 years or older), the membership entitles you to all the Annual Membership privileges.

Family Annual Membership:

This is for a Couple or Families with (2) or more riders (Husband, Wife and 2 children under the age of 18 living with the parents). After only a few visits as a family or a couple you begin to save every time you ride.
